1. Review Preliminary Recommendation for Personnel Wages and Benefits

Connie Wislinsky, Executive Director of Operations, and Agency Administrator Haynes reviewed the preliminary recommendation regarding wages and benefits. The Board received a summary of the recommended changes and the estimated cost. Variables included the use of the current CPI (1.96%) as the "default" increase, an estimation of the effect employee evaluation scores will have on the total cost, and one-time or "market" adjustments. There was discussion regarding how the coronavirus will affect the economy, if things don't improve should a smaller percentage be explored and if the board should wait and look again in May. The suggestion was made to possibly wait and make adjustments in September if needed.
