### ▶ REPORTS AND DISCUSSION ITEMS

### 1. Review Trust Fund

Connie Wislinsky, Executive Director of Operations, presented a review of the CESA 10 Trust Fund. The current position of the fund is that it is overfunded. This benefit is limited to a closed group of 34 employees with no new employees accessing this benefit. The latest actuarial study indicated the life expectancy of the OPEB and Pension benefits to be 10-11 years respectively.

The purpose of developing a trust has been met as CESA 10 has sufficient funds to meet the other post-employment liabilities obligations for eligible employees. For this reason, it is recommend transferring all funds invested in the variable interest rate account to the fixed rate account. This will protect the principal balance of the trust. It would be an unnecessary risk to keep investments in the variable rate account when the current investments are sufficient to cover liabilities and the number of eligible participants will not increase.

A special meeting is being held on October 15<sup>th</sup> at 6:00 pm to consider the approval of transferring the Trust Fund.

# 2. Department Update – Charlie Schneider, Executive Director of Facilities Management Charlie Schneider, Executive Director of Facilities Management, and Heather Feigum, Associate Director of Facilities Management, gave a department overview. Discussion and questions followed.

Mike Haynes, Agency Administrator, gave a review of his quarterly progress report for CESA 10. Discussion and questions followed.
