Marshfield Clinic AmeriCorps Member Serving CESA 10 Mental Health Navigator

Deadline for Application: June 3, 2022

Cooperative Educational Service Agency 10 (CESA 10) is looking for an individual to serve as a part-time (20 hours/week) Mental Health Navigator to be based in the CESA 10 area school districts. This is a grant funded paid experience in partnership with Marshfield Clinic AmeriCorps Community Corps program. The Mental Health Navigator is responsible to the Mental Health Consultant in the Special Education/Pupil Services Department. This individual will be trained to provide or develop mental health curriculums, such as Youth Mental Health First Aid and QPR, to school professionals, community members, and youth. The Navigator will support the CESA 10 Mental Health Consultant on providing mental health and school safety related coaching to school district leadership and multi-disciplinary teams that support youth. The Navigator will also help with program marketing and outreach services.

AmeriCorps is a federal service organization that partners with non-profits to serve communities. As an AmeriCorps member you are providing community service and volunteerism, but also receive a living stipend. Members receive an educational award for successful service. AmeriCorps service may double as internship experience for a degree program. You can attend school or work while serving.

Candidates are preferred to have, or be working toward, a Bachelor's or Master's Degree in an Education or Mental Health related field. A minimum of two years of experience working in an education and/or mental health related field is also preferred.

Benefits and Compensation:

- Modest Living Stipend
- \$3,247.50 educational award for successful service.
- Flexible hours (within 7am-4pm most weeks).
- May be eligible for loan forbearance and interest accrual payments with qualified student loans.
- Receive ongoing professional skills training throughout the program year. Gain experience valued by employers.
- Ideal gap year experience to explore health-related careers or paid internship experience.

Related Skills:

- Understanding and promotion of mental health literacy concepts (the knowledge, attitudes, and skills needed to develop and maintain positive mental health, identify mental health challenges in self and others, reduce stigma, and awareness of appropriate helping professionals).
- Broad understanding of the Wisconsin School Mental Health Framework.
- Effective communication and interpersonal skills, including the ability to present information to small and large audiences.
- Willingness to assist in coaching parents, teachers, paraprofessionals, administrators, and community professionals.
- Ability to create and publish mental health programming related content on all social media platforms.

Performance Responsibilities:

- Complete the full term of service, which is 900 hours. The 2022-23 AmeriCorps service term is September 12, 2022- August 31, 2023.
- Provide mental health and school safety training and consultation services to CESA 10 member districts and supporting community professionals.
- Assist in marketing mental health services and outreach through social media platforms.
- Travel to CESA 10 member districts and AmeriCorps trainings. Mileage provided for travel to districts. Mileage, meals, and housing are provided for all required AmeriCorps trainings and events.
- Attend all required AmeriCorps trainings
 - September 12-16, 2022 (orientation)
 - January 2023 TBD (midterm)
